The Managing Director, Karnataka State Tourism Development Corporation Ltd (KSTDC) invites the bids for sale of Old vehicles parked at KSTDC's Workshop, Yeshwanthpur unit as shown in the Annexure II. Sale will be conducted by way of calling Tender cum open action. The highest rates received will be considered for acceptance. The detailed terms and conditions are stipulated below.

The Bidder is requested to quote rates in the Bid application keeping in view of the terms and conditions of this Tender Document and the tender is liable to be rejected, if any changes in the terms and conditions are proposed.

GENERAL TERMS & CONDITIONS:

- 1. The bidder is required to clearly indicate their name, address and contact details on the sealed envelopes.
- 2. The bid application should be sealed and super-scribed as "TENDER FOR SALE OF OLD VEHICLES" and addressed to Manager (Transport), KSTDC, Corporate Office, BMTC-TTMC Bus Stand, Yeshwanthpur, Bangalore-560022.
- 3. **EMD**: The Bidder has to submit **Earnest Money Deposit (EMD)** of Rs.25,000/- (Rupees Twenty Five Thousand Only) through Demand Draft only (payment by cheque or any other mode is not acceptable) in favour of "**Managing Director, KSTDC**" payable at Bangalore. Tenders without the Earnest Money Deposit (Demand Draft Only) will be deemed rejected.
- 4. Interested parties may submit their bids in sealed envelopes duly super-scribed as "**Tender for sale of old vehicles**" on or before 11.08.2021 at 15.00 HRS at Corporate Office by addressing General Manager (Admin), KSTDC, Corporate Office, BMTC-TTMC Building, Yeshwanthpur, Bengaluru-560022. The Bidder is requested to self attest all the papers comprising the Bid application and Annexure attached.
- 5. Intending bidder may be inspecting the vehicles parked at KSTDC Workshop, behind Govt. Soap Factory, Industrial Area, Opp. TVS Centre, Yeshwanthpur, Bengaluru-560022 before 11.08.2021 at 12.00 PM.

Special Terms and condition

- 1. Bidders/contractors shall attach the scanned copies of PAN Card, Company Registration Certificates, GST & address proof / identification Proof pertaining to their pre-qualification.
- 2. Bids from persons who are black-listed, convicted, minors, who have failed to pay Government dues or who are insolvent will not be accepted and the EMD will be forfeited.
- 3. The bidders, shall at the time of submitting the bids, furnish his specific address and mobile / land line Phone Number to which all communication could be sent. KSTDC will not be responsible for the consequences (if any) due to communication sent to the address is not received by them. The responsibility to receive all communications shall fully rest with the bidder only.
- 4. The bidders should quote their highest price, exclusive of taxes for which bid is offered in Annexure-I (Scan and upload the offer price). In addition to payment of the tender amount, successful bidders shall also be liable to pay all statutory taxes, cess, fee, levy, etc., as per applicable statutes. The legal charges for conveyance, stamp duty and registration or any other charges as are applicable will have to be borne by the purchaser.
- 5. The acceptance of the bid will be communicated to the successful bidder within 30 (Thirty) days from the last date of auction by post. If any bidder withdraws his offer before the expiry of this period, the Earnest Money Deposit (EMD) will be forfeited to the Corporation.
- 6. Earnest Money Deposit (EMD) of the unsuccessful bidders will be returned to them after confirmation of the sale.
- 7. The successful bidders shall have to shift the vehicles in respect of which sale are confirmed within 7 (Seven) days of confirmation of sale. Failure to do so, within the said specified period would attract ground rent of Rs.250/-(Rupees Two hundred fifty only) per day. In any case, the successful bidders shall shift within 30 days of confirmation of sale otherwise they are liable to forfeit the amounts paid.
- 8. The successful bidder, as soon as his offer is confirmed and intimated, shall do full payment of the bid amount of vehicle within 10 (Ten) days from the date of confirmation. The amount should be paid in demand draft in favour of MD KSTDC, "The Karnataka State Tourism Development Corporation Ltd.", payable at Bangalore. Non-payment of the bid amount after acceptance of the bid by KSTDC will result in rejection of the bid and forfeiture of EMD, without any notice. KSTDC reserves the right to re-tender the sale and the defaulting bidders, shall have no claim over this.
